- Support and contribute to the advancement of solar in Canada.

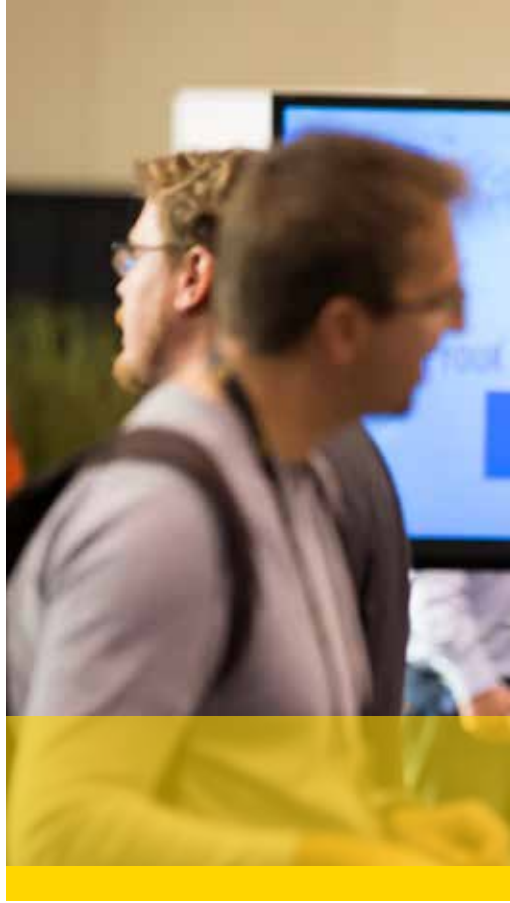

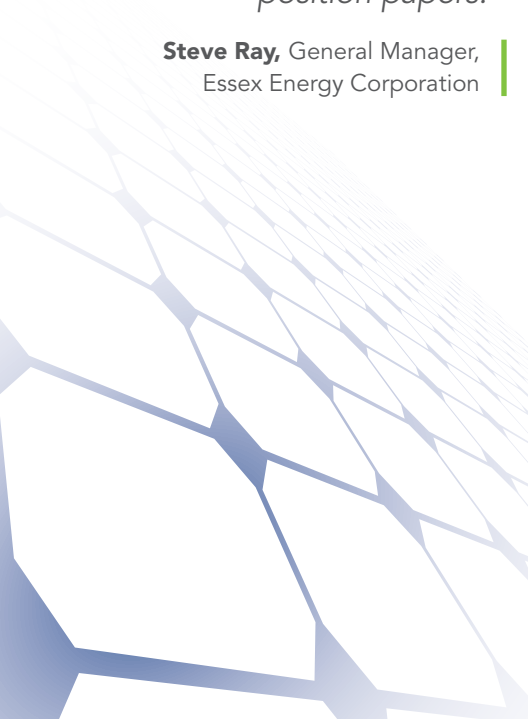

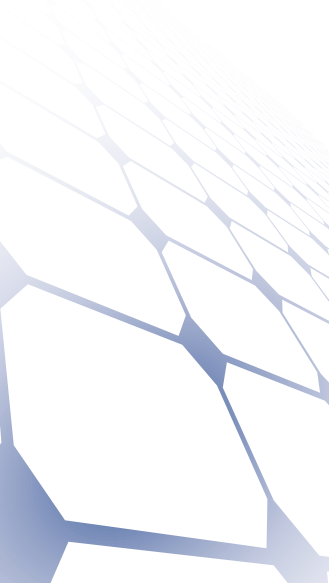

CHOOSING A MEMBERSHIP LEVEL

Three levels of Corporate Membership are available for small to large corporations, either working as part of the industry or as a service provider to the industry. Membership level is selected based on company size and membership objectives.

C1 (Industry Leader)

Corporate Level 1

Annual Fee: \$10,000

25+ employees OR > \$10 million annual solar revenue OR 10+ MW in solar assets

C2

Corporate Level 2

Annual Fee: \$4,000

5-24 employees OR \$2-10 million annual solar revenue OR < 10 MW in solar assets

C3

Corporate Level 3

Annual Fee: \$1,000

< 5 employees OR < \$2 million annual solar revenue (Not available for publicly traded companies)

S1

Supporter Level 1

Annual Fee: \$3,000

Municipalities, government departments, utilities, regulators

S2

Supporter Level 2

Annual Fee: \$500

Non-profit organizations, educational institutions, community groups
